SUMMARY ANNUAL REPORT FOR PLUMBERS' WELFARE FUND, LOCAL 130, U.A.

This is a summary of the annual report for Plumbers' Welfare Fund, Local 130, U.A., EIN 36-4026252, for the year ended May 31, 2020. The annual report has been filed with the Employee Benefit Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Basic Financial Statement

Benefits under the plan are provided by Trust.

Plan expenses were \$73,417,921 consisting of \$70,952,897 of benefits paid to participants and beneficiaries, \$561,625 of professional fees, \$378,672 of investment fees, and \$1,524,727 of other administrative fees.

The value of plan assets, after subtracting liabilities of the plan was \$166,749,325 as of May 31, 2020, compared to \$158,592,197 as of June 1, 2019. During the plan year, the plan experienced an increase in its net assets of \$8,157,128. This increase included unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of \$81,575,049 including (but not limited to) participant contributions of \$523,826, employer contributions of \$70,462,837, and earnings from investments of \$10,560,933.
