Business Manager's Letter

From James F. Coyne

Greetings Brothers and Sisters,

I hope you and your family are well, and looking forward to the holiday season.

Plumbers Local 130 was formed in 1895, and today it surpasses 6,000 members. Our success is due in part to the partnership formed with our contractor employers. The Plumbing Industry has shared a vision, which is water conservation. This concept prompted our campaign to build a "state-of-the-art building" to prepare our future apprentices and journeymen for the 21st Century's plumbing needs. The new three-story JAC Training Center is up and running, once again due to the collaboration between labor and management led by Craig Thomas, JAC Management Co-chairman and Matt Erikson, JAC Treasurer.

On September 12th, our Joint Apprentice Committee's Board of Trustees, along with Local 130 Officers, Instructors and Apprentices welcomed over 350 dignitaries and guests at the Plumbers UA Local Union 130 JAC Training Center's Grand Opening and Ribbon Cutting Ceremony. Elder Kevin Ford, St. Paul Church of God in Christ Community Development Ministries, Inc., offered an uplifting and positive invocation. UA General President Mark McManus addressed the standing room only crowd and referred to our facility as "A spectacular building that is preparing plumbers

for the future." Other dignitaries spoke, including Illinois Speaker of the House Michael J. Madigan; Amy Rule on behalf of her husband Chicago Mayor Rahm Emanuel; Illinois State Representative and Local 130 member John D'Amico; Chicago Department of Buildings Commissioner Judy Frydland; Chicago's 27th Ward Alderman Walter Burnett, Jr.; and W.E. O'Neil Construction Company President John Russell.

In the evening, a brief membership meeting was held with over 800 members in attendance. Following the meeting, the members toured the new Training Center and enjoyed a Patio Party hosted by the Local 130 officers. UA General President Mark McManus spoke to the members and was passionate about the UA's future. He stated, "I've been all over the country, and bar none, this is the finest facility in the UA. The standards have been raised!" The members responded with a standing ovation.

The Training Center was built in just 16 months beginning in April 2016. This project was successful due to the team collaboration between the JAC Building Committee, Gensler Architects, and General Contractor W.E. O'Neil Construction Company. Our main sub-contractors were Chas. F. Bruckner & Son (*Plumbing*), Edwards Engineering (*HVAC*), Nova Fire Protection (*Sprinkler Fitters*), and Sharlen Electrical Company. I would like to say a sincere thank you to all our union sub-contractors

and building trades workers for their outstanding craftsmanship.

Guests and members were impressed with the water conservation methods showcased throughout the center. From the main lobby you can see the large rainwater harvesting tank system. The classrooms have opened a new era of hands on education. Apprentices will learn how to design energy efficient systems; install, repair and service high-end plumbing systems; solve customer problems; and most importantly protect the health of the nation.

In May, as the final stage of the new Training Center was in progress, Cody Albergo was named Chicago's #1 Local 130 Apprentice at our annual in-house competition. I wish Cody good luck as he moves on to the UA State Apprentice Plumber Competition in March 2018. In June, three new instructors were hired. They are Brian Anderson and John Majerowicz teaching in Chicago, and Scott Poole is teaching at the Volo School.

Please continue to read through the newsletter for more news and information. As always, I wish you good health and prosperity, steady employment and happiness. Best wishes to you and your families as 2017 comes to an end. Merry Christmas and Happy New Year!

Pension and Welfare Benefit Office

Frequently Asked Questions Related to your Health Benefits with Plumbers' Welfare Fund, Local 130 U.A.

1. What types of expenses are reimbursable under the Health Reimbursement Account (HRA) with TASC?

You can receive reimbursement from your HRA with TASC for numerous types of medical expenses such as:

- Your Deductible
- Self-Payments under the Active Plan or COBRA Payments
- Self-Payments under the Retiree Plan
- Co-Payments for Medical Expenses – including Co-Payments for Prescription Drugs
- Any amounts that exceed Plan limits for dental benefits, hearing benefits, or vision benefits (including LASIK surgery)
- Amounts charged by a Physician that exceed the Reasonable and Customary charge for a procedure or treatment

Fees for Health Club Memberships ARE NOT reimbursable from your HRA with TASC.

2. Do I receive any type of benefit from the Welfare Fund for joining a Health Club?

Yes. Although fees for Health Club Memberships **ARE NOT** reimbursable from your HRA, you and your spouse will receive credits to your HRA if either of you utilize a health club membership. If you or your spouse has 150 or more health club visits during a calendar year, you or your spouse will receive a \$300 credit to the HRA. If you or your spouse has 100 to 149 health club visits, you or your spouse will receive a \$200 credit to the HRA. If you or your spouse has 50 to 99 health club visits, you or your spouse will receive a \$100 credit to the HRA. Visits by you and your spouse may not be combined to reach the required number to receive HRA credit. Credits to the HRA will be made

once the Fund Office receives your health club membership invoice and proof of visits (visit log from the health club).

3. Does the Welfare Plan have a Substance Abuse Benefit?

Yes. The Welfare Plan utilizes the Blue Cross Blue Shield network of providers. For In-Patient services, the Substance Abuse Benefit covers 100% of the first \$2,000 of eligible expenses, and then 90% of all amounts exceeding \$2,000 for **in-network** providers. For Out-Patient services, the Substance Abuse Benefit covers 100% of the first \$1,000 of eligible expenses, and then 80% of all amounts exceeding \$1,000. **You will always pay less money out of pocket if you use an in-network provider.** Always ask your provider if they participate in the Blue Cross Blue Shield network so that you can maximize the savings available to you. To determine if a provider is in-network, please visit the Blue Cross Blue Shield web site at www.bcbsil.com or call 1-800-810-BLUE (2583) for a list of in-network providers. You can also contact the Funds' Member Assistance Program (MAP) for assistance with selecting an appropriate provider for substance abuse counseling. The MAP will ensure that you receive a professional assessment of your situation by a licensed clinician and offer referrals to an in-network provider. Before you seek treatment, please contact the MAP at 1-800-292-2780.

4. Can I use an Out-of-Network Provider?

Yes. The Welfare Plan covers medical procedures offered by Out of Network providers. However, as of December 1, 2016, all out-of-network claims must be submitted to the Fund Office for pre-authorization which will then be reviewed by the Fund's Peer Reviewer, Hines and Associates. Out of Network claims that are NOT pre-authorized prior to treatment are subject to denial with no benefits paid from the Welfare Fund. Once again, you should ALWAYS use an in-network provider for ALL your medical needs. The Welfare Plan will pay 70% of the Reasonable and Customary fees or charges of an Out-of-Network Provider.

The Labor Day Festival was held at Steelworkers Park located at 87th and Lakeshore Drive and offered a weekend filled with activities, good music, food and drink.

Edward F. Goldacker, a retired 71-year member of UA Local 130, worked for several plumbing companies throughout his career, which included Great Lakes Plumbing & Heating and Fettes, Love & Sieben. Ed stated, “I turned 92 years old and can honestly say that I live like a king because of Plumbers Local 130’s union contracts that secured my benefits.

Ed’s father, Edward H. Goldecker, Sr. was a Local 130 union forerunner, and little did he know that his skills and integrity would be used in the creation of a new energy source. An era of scientific and technological advances was in progress at the University of Chicago.

Edward, Sr. left grammar school to help his brother Louis, who was a plumber. They hauled lead water pipe and supplies by horse and cart around the Ravenswood and Belmont area. Edward, Sr.’s job was to take care of the horses. As Edward, Sr. was turning 16 years old, World War I broke out and he served in the United States Navy. After returning to Chicago, he joined Local 130. There were hard times again when the depression hit, but then in 1939, Edward, Sr. started working for O’Callaghan Plumbing. He received a phone call from Mr. O’Callaghan asking him to come to the office for a meeting. Mr. O’Callaghan explained that due to the younger men getting drafted, a maintenance worker was needed at the University of Chicago. My father was told emphatically, “Do not call the shop; the university will have all the tools and materials needed, and your paycheck will be mailed.” Since gas was rationed, he was allotted extra gas stamps, which guaranteed his arrival on the job.

After three weeks, Edward, Sr. was instructed to report at the old Stagg Football Stadium. He had an assigned helper who would do no work, only keep him company. There wasn’t much to see under the stadium. It was filled with

small rooms, and the walls and ceilings were covered in canvas. The lead pipes, solder, furnace, tools and other materials to mount the pipes were stored in one of the canvas rooms. Edward, Sr. received written instructions with tasks such as: run 3/8” pipe six inches past the hole marked “A,” solder 1/2” branch pipe to 3/4” pipe and extend it one foot past canvas in the hole marked “B,” etc. The helper stayed all day, even during their brown bag lunch break.

When Edward, Sr. asked, “What’s going on? I know I’m being followed.” The helper stated, “A cure for trench foot disease is being developed, which would give our soldiers a big edge over the Japanese.” The helper asked that my father continue to be silent about his work. No one should be told anything! My father never found out if other Local 130 Plumbers were involved in the project.

Scientists split the “Atom” under Stagg Stadium. This atomic energy created a chain reaction for mankind. The development of the “Atomic” bomb ended World War II earlier than predicted, which saved hundreds of thousands of lives. It also produced atomic powered naval ships, as well as clean atomic energy for our country.

Ed stated, “I just didn’t want this story forgotten. I’m proud that a Local 130 member participated in this historical project.”
