## Business Manager's Letter

From James F. Coyne

Greetings Brothers and Sisters,

It's hard to believe that spring is nearly over and summer is here. I hope you and your family are well. It was a productive first quarter for Local 130 as improvements were made on our Wage and Benefit Package, a new Apprentice class started, future building projects are in progress, and of course, the 63rd Annual Plumbers Local 130's St. Patrick's Day Parade was a success.

At the April 10<sup>th</sup> membership meeting, the June 1, 2018 Wage & Benefit Allocation was presented and received concurrence. Based on a recent study by The Segal Company, Plumbers Local 130's pension is funded 93% and solvent. (See page 6 for more detailed information.) Also, the members at the meeting voted to increase the Target Fund payroll deductions to \$.55 per hour. This is an increase of \$.10 per hour for Plumbers and \$.30 per hour for the Technical Engineers. The Target Fund has been successfully used for the Plumbers 911 Service Program, funding Schedule A Residential New Construction, as well as helping signatory contractors win bids on projects that might otherwise be done by a non-union contractor. Advertising for the Plumbers 911 program continues to help establish the brand and secure more service jobs; however, this is an on-going battle and there is more work to be done.

## BUILDING FOR THE FUTURE

The property to the north of the Hall is owned by Plumbers Local 130 and is presently used as our parking lot. As you know, the west loop property is prime real estate due to new construction, the influx of major corporations and visitors. A proposal to construct a multi-level parking structure was explained to the membership during the April 10<sup>th</sup> meeting. The members voted to establish a new Building Fund. A payroll deduction of \$0.25 per hour was approved by 89% of the voting members. Parking will be available free of charge for all Plumbers Local 130 members. The revenue produced from rental spaces will help defray the costs of maintaining the Chicago Hall, Volo Hall and the Joliet and Warrenville satellite offices. There will be more information on this project at our next meeting and in future newsletters.

On April 23<sup>rd</sup> a new class of apprentices started their orientation week at Chicago's JAC Training Center. The following Monday, April 30<sup>th</sup>, 137 men and women began working with our signatory contractors. Over the past three years, the JAC has had a new apprentice class start in the spring and the fall due to contractors' demands.

As Chairman of the JAC Joliet School, along with Management Co-chairman Craig Thomas and the Board of Trustees a plan is being developed to revitalize and upgrade the facility. There are no definite remodeling plans yet, but I will keep you updated.

The Political Action Task Force (PATF) volunteers went to several locations on four Saturdays, February 17<sup>th</sup> and 24<sup>th</sup>, March 3<sup>rd</sup> and 10<sup>th</sup> supporting labor-friend-

ly politicians who protect our plumbers license law. Plumbers Local 130 is an advocate for the blue-collar workers; therefore, supports Democratic candidate JB Pritzker for Governor. Thank you to Mike Tierney, Director of Political and Municipal Affairs for spearheading efforts, as well as the 250 volunteers who participated each Saturday and made our PATF campaigns successful.

Rebuilding Together Metro Chicago was held on Saturday, April 28<sup>th</sup>. This year our volunteers helped renovate homes of disadvantaged residents in the North Lawn-dale neighborhood of Chicago and the suburb of Bellwood. Thank you to all our members who volunteered their time for this community program. I want to give a special thanks to Business Agent Michael Shea and Organizer Paul Rodriguez for going above and beyond preparing for this day. It takes several months to assess homes, order supplies and schedule volunteers. (More to follow in summer newsletter)

Finally, mark your calendars for our 25<sup>th</sup> Annual Football Smoker, which will be held on Sunday, November 4<sup>th</sup>. (See invitation on last page). Please continue to read through the newsletter for current news and information concerning Local 130 U.A. I look forward to seeing you at the next meeting. We succeed and thrive based on how each and every member participates and supports Plumbers Local 130. As always, I wish you good health and prosperity, steady employment and happiness.



# Plumbers Local 130's – 63<sup>rd</sup> Annual St. Patrick's Day Parade

On Saturday, March 17<sup>th</sup> our 63<sup>rd</sup> Annual St. Patrick's Day Parade recognized "The Irish Bond of Community and Service." The City of Chicago is renowned for its skyline, architecture, excellent museums, restaurants, and a strong infrastructure. This year's Grand Marshal was 40<sup>th</sup> Ward Alderman Patrick J. O'Connor and the Guest of Honor Illinois Supreme Court Justice Anne M. Burke. Both honorees have represented Chicagoans for many years with their services.

Alderman O'Connor stated, "As a former Teamster union member myself, I have great respect for the men and women who keep Chicago moving forward. My father encouraged me to go into a profession of service, so that I could give back to my community." In 1968, our Guest of Honor was the driving force behind the creation of Chicago's Special Olympics. Illinois Supreme Court Justice Anne M. Burke will celebrate its 50<sup>th</sup> Anniversary in July 2018. She has promoted, supported and helped countless children and adults with special needs.

It was a cold morning, but ABC Channel 7 was at the Chicago River while our plumbers turned it an emerald green. Once again, their team televised the parade for two hours. For many plumbers and their families the day started at the Union Hall with coffee, juice and pastries. # Pension and Welfare Benefit Office

I hope everyone has shaken-off the winter blues and is ready to settle into some nice, comfortable spring weather.

One of the goals of the Board of Trustees is to continuously look for ways to pass along benefit improvements to the Participants and their families. That stated, I am happy to highlight the following benefit improvements to the **Retiree Medical Plan of Benefits and the Plumbers' Pension Plan**:

## Retiree Medical Plan of Benefits:

### 1. Out of Pocket Maximum

Effective January 1, 2019, the Out of Pocket Maximum for Pre-Medicare Retirees in the Retiree Medical Plan will be reduced from \$5,000 annually to \$2,000 annually per individual. After an individual's Out of Pocket expenses reach \$2,000 annually, the Plan will be 100% of most of the individual's covered expenses during the remainder of the Calendar Year. Remember, medical expenses incurred while using an Out-of-Network provider do not count toward the Out of Pocket Maximum.

### 2. Improvements in Dental Coverage

Effective January 1, 2019, the following benefit improvements will become effective in the Dental Plan for Retirees:

- The Annual Maximum benefit payment for dental services will increase from \$1,000 to \$2,500 annually, and
- The co-insurance level for Basic and Major Restorative services will increase from 50% to 80%

### 3. Increase in the Chiropractic Care Benefit

Effective January 1, 2019, the Annual Maximum for Chiropractic Care benefits for the Retiree Medical Plan will increase from \$1,000 to \$2,000.

### 4. Improvements in Vision Coverage

Effective January 1, 2019, the following benefit improvements will become effective in the Vision Plan for Retirees:

- The \$10 co-payment for an Eye Examination is eliminated.
- The \$20 co-payment for Eyeglasses and Contact Lenses is eliminated.
- The Annual Maximum benefit for Eyeglasses or Contact Lenses will increase from \$150 to \$350 in a 12-month period.

## Plumbers' Pension Plan

Plumbers Pension Fund Co-Chairs James Coyne and Michael Kerrigan, along with the Board of Trustees worked together to make the following benefit improvements:

The accrual rate for Active participants will increase from \$125 to \$140 per pension credit for work performed *after* June 1, 2018. In addition, the accrual rate per pension credit will increase by \$15.00 per credit for worked performed in covered employment retroactively to June 1, 2014. For example, if you worked at least 1,200 hours in the Plan Year June 1, 2014 to May 31, 2015 your pension accrual rate for the Plan Year was \$115.00. With this benefit improvement, the \$115.00 pension accrual rate will now be worth \$130.00. In order to receive this benefit improvement, you must: 1) work at least 1.00 hour or more in covered employment on or after June 1, 2018, and 2) your First Retirement Date must be on or after June 1, 2018.

Lastly, in order to recognize the hard work and dedication of our retired Plumbers, the Board of Trustees voted to award a Bonus check to Retirees and Beneficiaries that are receiving a monthly pension benefit as of June 1, 2018. The Bonus check will be issued on or about Friday, June 15, 2018.

# June 1, 2018 Wage & Benefit Allocations

## PLUMBERS

Plumbers Local 130 UA members received their annual pay raise on June 1, 2018. The increase depends on which signatory contractor's group represents your employer (see tables below). For the plumbers, the amounts were negotiated as part of a three-year agreement between Local 130 and three employer groups. The current agreements will expire on May 31, 2019. The journeymen plumber's wage rate (on the check) is \$50.25 per hour if working for a PCA or WSA employer and \$47.36 if working in Kankakee/Iroquois Counties (K&ICPPA)

## TECHNICAL ENGINEERS

For the Technical Engineers who work in Indiana, the four-year agreement with the Mid-America Regional Bargaining Association (MARBA) will end on May 31, 2019. The Journeymen's rate for those members working in Illinois has increased to \$46.85 per hour. For the Technical Engineers who work in Indiana, the recently negotiated one-year agreement with Northwest Indiana Contractors Association (NWICA) will also end on May 31, 2019. The Journeymen's rate for those working in Indiana has increased to \$41.25 per hour. A newly negotiated Defined Contribution Pension has been added for the Technical Engineers working under the NWICA Agreement.

**The following are just a few items that members may not know . . .**

**Social Security Disability Dues Assistance:** Letters were recently mailed out to members identified as being on Social Security Disability. The letter is to inform them that their monthly window dues will be waived per our current bylaws. The Union will pay their per-capita to the United Association to keep them a member in good standing. If you are currently on Social Security Disability and did not receive a letter, please call me at (312) 421-1010, ext. 117.

**Parking Lot:** Our parking lot is a very busy place and we often have events that require assigned parking. Please respect our staff and security guards at all times when parking in the lot. **Window Dues Payment:** Effective April 1, 2018, the membership voted to unanimously increase window dues to \$32.00 per month for active members and \$15.00 per month for retired members.
