We are in the final stages of completion at our new state-of-the-art training center in Joliet. We received grant money from the ITF that will help equip our Joliet training center.

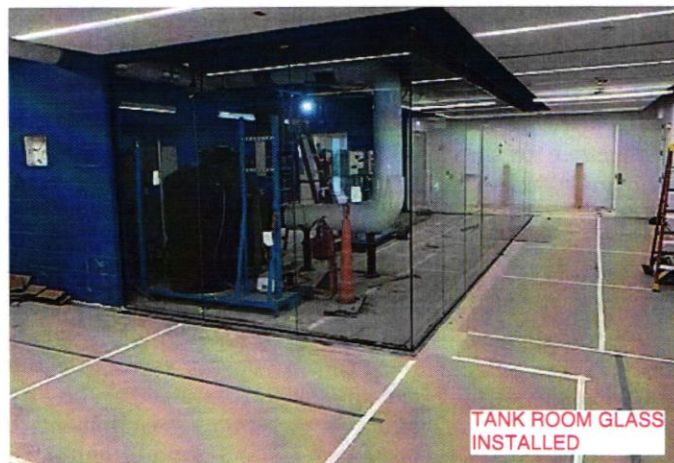

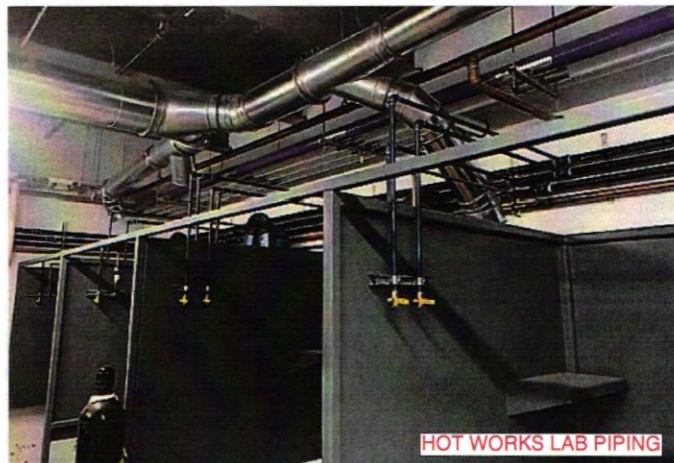

The 2020 Pandemic did not stop our 2021 Apprentice Contest from moving forward. The competition took place on March 20, 2021.

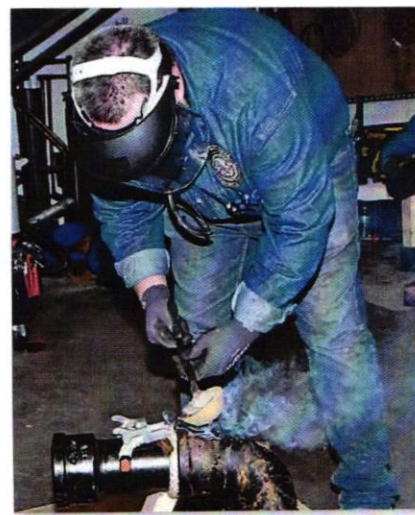
Select third year apprentices were invited to compete in the Plumbers Local 130 Third Year Apprentice Contest for 2021.

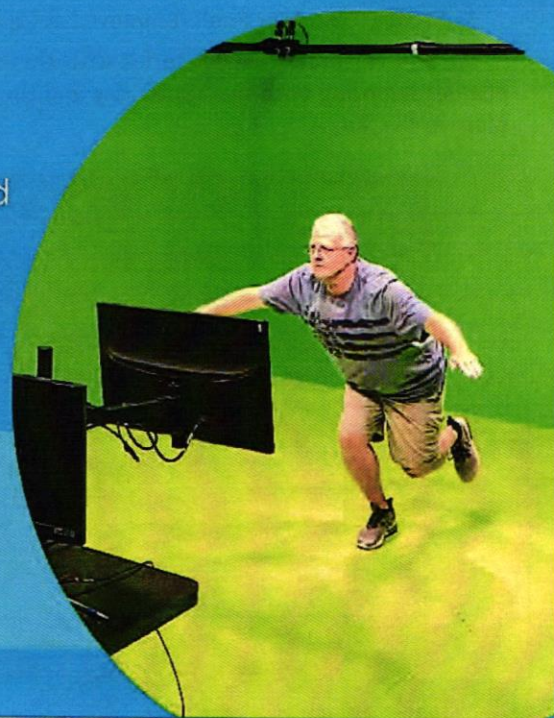

## Wellness Center Winners



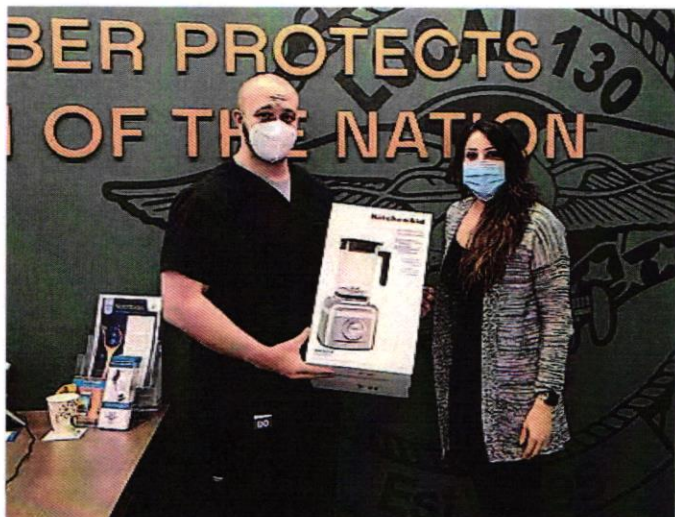
