According to Article V. Section 1 of the Constitution & By-Laws of the Chicago Journeyman Plumbers' Local Union 130 UA. "Nominations for the Election of Officers and elected Standing Committees shall be made from the floor at a regular meeting in the month of May". Therefore, nominations for the following offices shall be made orally from the floor during our regular meeting on May 14, 2024. This meeting will be held at 1340 W. Washington Blvd. beginning at 6:00 PM

A live stream of the May 14, 2024 meeting will be provided in Joliet and Volo. Nominations can be made **ONLY** from the floor in Chicago. Please attend the meeting in Chicago if you intend to make any nominations.

Section 6 of the Article continues, "The Election of Officers and Standing Committees shall take place at the regular meeting in the month of June". According to Section 122(a) of the Constitution of the United Association "All officers of Local Unions shall be elected for a term of not less than three (3) years". Therefore, our meeting on June 11, 2024 will be set aside for the purpose of conducting the election. Members wishing to exercise their privilege to vote will be able to cast their ballots at one of three locations: 1) 1340 W. Washington Blvd., Chicago; 2) 2114 I-80 South Frontage Rd., Joliet; or 3) 31855 North US Route 12, Volo, between 10:00 AM and 7:00 PM. In the event of a tie vote for any office, thereby making a runoff necessary, such runoff will be held on Thursday June 20, 2024 between the hours of 10:00 AM and 7:00 PM at 1340 West Washington Blvd.


We call your attention to Article V. Section 4 of the Local Union's Constitution as well as Section 121 of the Constitution of the United Association, which define the rules of eligibility for Office in Local Unions. "No member shall be eligible to be nominated for office unless he shall have been a member in good standing of the United Association and this Local Union for at least a period of two (2) years immediately prior to the date of election. Any member who owes or had paid a reinstatement within a period of two (2) years immediately prior to the date of election shall not be eligible to be nominated for office in this Local Union."

We now call your attention to Section 124(a) of the Constitution of the United Association, which define the rules of eligibility for participation in elections. "No member shall nominate candidates for or vote at any election of any description in the Local Union where the vote is being taken unless he has been a member in good standing in the Local Union where the vote is being taken for a period of one (1) year immediately prior to the date of election. Any member who owes or has paid a reinstatement fee within a period of one (1) year immediately prior to the date of the election shall not be eligible to nominate candidates for or vote in any Local Union election." See also Article V. Section 8 of the Local Union's Constitution: "No member shall be eligible to vote at any election of this Local Union unless he has been a member in good standing of this Local Union for a period of one (1) year immediately prior to the date of election. Any member who owes or has paid a reinstatement within a period of one (1) year immediately prior to the date of the election shall not be eligible to vote."
