June 1, 2024 Wage & Benefit Allocations

PLUMBERS

Local 130 UA members have received their annual wage and benefit increase on June 1, 2024. The amount of the increase depends on which signatory contractor association represents your employer (see tables below). For the plumbers, the amounts were negotiated as part of a four-year agreement between Local 130 and three associations. The Journeyperson Plumber's wage rate (on the check) is \$58.55 per hour if working for a PCA or WSA employer and \$53.70 if working in Kankakee/Iroquois Counties (KICPPA).

The Journeymen Plumbers wage rate (on the check) is \$52.00 per hour if working under the Schedule A Agreement and \$48.70 if working under the Residential Service Agreement.

TECHNICAL ENGINEERS

For the Technical Engineers who work in Illinois, this is the fifth year of a five year agreement that was negotiated with Mid-America Regional Bargaining Association (MARBA) and Plumbers Local 130. Technical Engineers did receive their wage and benefit increase on June 1, 2024. The Journeyperson's rate for those members working in Illinois has increased to \$56.50 per hour. For the Technical Engineers who work in Indiana, this is the fifth year of a five year agreement with Northwest Indiana Contractors Association (NWICA) which began on June 1, 2024. The Journeyperson's rate for those members working in Indiana has increased to \$48.70 per hour. Listed below please find the allocation of the hourly increase for 2024.

Pension Benefit Update:

The Trustees of the Plumbers' Pension Fund, Local 130, U.A. (Pension Fund) are pleased to announce the following new benefit improvements to the Plan.

These improvements are effective for retirement dates on or after June 1, 2024:

Increase in the Benefit Accrual Rate

A Participant whose Retirement Date begins on or after June 1, 2024, and who completes at least one(1.00) hour of service in Covered Employment on or after June 1, 2024, will receive a Pension Benefit Accrual Rate of \$180.00 for each full Pension Credit earned on or after June 1, 2024. This is an increase of \$20.00 from the current Pension Benefit Accrual Rate of \$160.00.

Increase in Bonus Credit Rate

Currently, an Active Participant receives a full Bonus Credit by working at least 1,500 hours in Covered Employment during a Fiscal Year. A Participant earns additional full Bonus Credits by working in Covered Employment up to 1,800 hours, 2,100 hours and 2,200 hours – for a maximum of 4 Bonus Credits in a Fiscal Year. Each Bonus Credit is worth \$10.00.

Effective June 1, 2024, any full Bonus Credits you earn working in Covered Employment after that date will be worth \$20.00 each.

BONUS CHECK

All Pension Fund participants who received a pension benefit as of June 1, 2024 should have received an additional one-time bonus check in the amount of \$1,778.00 on or about July 15, 2024.



Union Eyes: A Message From Dr. Lisha Patel, Optometrist

Eye injuries in the workplace are extremely common. An estimated 2,000 work related eye injuries occur every day. These can range from mild eye strain to severe trauma which can cause permanent eye damage or vision loss. As a health-care professional, my hope is that workers and employers will prioritize the protection of vision, the most important of the body's senses.

Recently, I had a Local 130 member present to my office because he felt like there was something in his eye. He had gone to the immediate care center a week earlier and they sent him home with some eyedrops saying everything was fine. He came in saying his vision was blurry and that he still felt something in his eyes. I then examined his eyes with my microscope and saw a piece of fiberglass embedded in his cornea, which is the front surface of the eye. After numbing his eyes, I was able to remove that piece of fiberglass. If a foreign body is not removed promptly, it can be pushed progressively deeper into the cornea causing more damage and potential scar formation. As a result

of the patient coming in that day, he avoided further complications and more importantly received immediate relief.

I cannot stress enough the importance of maintaining healthy eyesight in the workplace. Please come in the next time you need emergency eye care. Our dedicated team is available for you at one of our eight Union Eyes locations 24/7.

You can call our number even after hours, and someone will be able to assist you. After all, your vision matters around the clock. Save yourself the hassle and come see us first for your eyecare needs.


